1.	Technical specification of Tractor for Mechanical Sweeper were not in bidding documents.	It is also mentioned in technical specifications of Tractors i.e. 50 HP or above		
2.	Sample Picture for dustbin. According to given specification these dustbin were simply placed on road side or need any installation and waste bin can be either plastic or metal	The manufacturing material for the dustbin will be HDPE (Virgin/Recycled) or equivalent contractor will provide separate rates for both virgin and recycled.		
		Please note that the bidder shall provide a sample before submission of the bid for approval.		
		The bidder will also provide life cycle/warranty of five years minimum		
3.	Vehicle and Manufacturing/ Fabrication are different, as Chassis assembler quote for Vehicles and Manufacture/Fabricator for fabrication and installation of super structure on chassis. Bidder can Bid separately for example Vehicles or Fabrication part only	Bidder will quote rates for complete unit.		
4.	According to PPRA vehicles/Chassis purchases directly from chassis assembler or through Tender. After this separate tender for Fabrication and installation of superstructure on it from manufacture/Fabricators	The subject procurement is governed by the World Bank Procurement Guidelines January 2011 (updated on July 2014). Bidder will quote rates for complete unit.

Not Applicable as per ITB Clause 34.6 (C). however the bidder is bound to provide any maintenance/complementary/free of cost as per manufacturers company policy
